***Instructions for Parent(s), Guardian(s):***

- The Southern Sierra Council, Boy Scouts of America Campership Fund provides funding for registered Scout members of Southern Sierra Council.
- The Campership Fund is used specifically for Southern Sierra Council's outdoor programs, including but not limited to: Camp Kern Boy Scout Camp, Cub Scout Resident Camp and Cub Scout Day Camp.
- Funding for support of the Campership Fund is received through foundations, service club organizations, businesses and individual community donors.
- The purpose of the Campership Fund is to provide every registered Scout of Southern Sierra Council an opportunity to experience traditional, values-based program through outdoor camping activities.

**Note: Campership applications are NOT registration forms for camp. A Campership application is a request for financial aid. Please file the appropriate camp reservation form(s) required for camp attendance.**

1. Due to the large number of Campership requests, funding will be allocated only to registered youth members of Southern Sierra Council, Boy Scouts of America.
2. Campership funding is only available for camp(s) operated by Southern Sierra Council, Boy Scouts of America.
3. Campership Fund requests should be made a minimum of thirty (30) days prior to the opening day of camp, although earlier submissions are appreciated.
4. The confidential Campership Fund application must be completed in full and signed by the applicant and the parent/guardian.
5. Use one (1) Campership Fund application per applicant. Additional applications are available online at: [www.campkern.net](http://www.campkern.net) or [www.sscbsa.org](http://www.sscbsa.org).
6. Mail completed Campership application(s) to: Southern Sierra Council, BSA, 2417 M Street, Bakersfield, CA 93307, Attention: Campership Fund
7. Recipients of Campership funding agree to participate in Southern Sierra Council's next annual Popcorn fundraiser following the receipt of Campership funds.
8. Applicants will be notified by mail regarding approval or denial of their request for Campership funding prior to the opening day of camp.

**A Campership Fund application requesting allocation for total camp fees is seldom given. Each Scout, parent, guardian, Pack, Troop, Crew, Team or Post granted campership funds is responsible for payment of the remaining balance of fees not covered by the Campership Fund. Approved applicants will receive by mail a notice of the approval of campership funds and a statement with the remaining balance of fees due.**
